Section 2:12 Emergency or Transition Board Provision

In a situation where the organization is faced with an emergency or crisis situation, and the Sitting Board is unable or unwilling to remain due to term completions, conflicts of interest, or other factors, the Sitting Board may convene a temporary Transition Board to serve during that period.

The Transition Board must be comprised of a minimum of five (5) members, at least one (1) of which must be an independent voting member of the currently seated Board to provide continuity of governance. Remaining members of the Sitting Board may be drawn from those who have served complete terms, waiving the mandatory sabbatical year. The Transition Board may serve no longer than 18 months, by which time they shall have resolved the crisis and reinstated the Standard Board based on the parameters set forth in these Bylaws. The Transition Board must be voted in by the Sitting Board by two-third (2/3) majority vote of all Sitting Board members. Members of the Transition Board may become members of the reinstated Board, as desired, once the transition period is completed and the Standard Board terms apply.
